Even in the democratic country the bureaucratic individuals are powerful enough to have a hostile takeover or to get a control of a country or political organization by using their evil force of bureaucracy. Therefore, the title of this article is "Bureaucracy: An evil force to takeover democracy."

Democracy is a system of the country in which every citizen can vote to elect its Member of the Parliament (MP) or the electoral body. In the regime of military rule, non-democracy, communism, anarchism, fascism and kingship including the regime of Middle-Eastern countries, there is no democracy in the sense of reality. In the democratic system, everyone is equal in the eye of rules and regulation and the judiciary system. Everybody has the right to vote and make voting decision by himself. Democracy can also have a role-play within the association or the trade-union and the related organization. Democracy is the one which believes in the sense of democracy or in which people work to achieve democracy. In USA, "Democrat" is a member or supporter of the democratic party. Manufacturing sector in the democratic society will enjoy some kind of advantage from the democratic government such as less tariff or less import duty for the import of essential materials including raw materials. In other cases, tax free import of machineries in the manufacturing sector is expected to be encouraged by the democratic government. In some sector such as fish farm, livestock, dairy, poultry etc substantially receives a long-term tax holiday. The above policies are the people's expectation and the government responsibilities to perform in the democratic society.

Common people would like to avail quality goods and services at a fair price. Democratic government will look into it by providing a congenial environment of higher productivity and services at home. The political ideology of the democratic government will also encourage to import goods and services from foreign countries at fair price. People will also expect to have employment creation to increase their placement opportunity and better jobs etc. Democratic government will provide a secured investment in the manufacturing sector through a few mechanism including share market. The democratic government will also perform by ensuring a safe and secured investment policy in the production sector which will, in turn, help alleviate the poverty.

Traditionally people would to avail, an environment of quality education and quality health services. But in a large country of 158 million people of Bangladesh with a low level of tax profile, the government cannot provide all these by itself. Therefore, the democratic government will take a liberal policy to help facilitate the establishment of educational institution at all levels and the healthcare center of all size in the private sector. The food and nutrition are among the very few basic needs in life. But the cost of production in agricultural sector is essential. The democratic Government will do it in a relatively more equilibrium fashion. Consumer will do it in a relatively more equilibrium al sector in a smart and very intelligent way. Precisely speaking, over-and under production in any sector and in agricultural sector is not expected. In the year of the recent past (2011), total potato production in the Northern region was 83 thousand ton against the consumer demand of 58 thousand ton.
