OST of the people in the world are poor. Ten years ago about 40% of the total population of Bangladesh were below the poverty line. According to official data, the level of poverty in the country has recently been on the decline - from 40% to 33%. It means that more than 50 million people in today's Bangladesh are still poor. Most of the poor people are poor from their childhood.

This scenario of poverty in Bangladesh is not significantly different from the average global syndrome. In most countries and with most of the people worldwide, poverty starts from childhood.
